## TERMS OF DELIVERY, NEW ISSUES SERVICE LISC Chapter 7

(decided in the LISC-meeting of september 23, 2000)

New Issues will be delivered according to the terms mentioned below:

1. New Issues will be delivered according to a filled up and undersigned subscription form.
2. New Issues will be delivered on the basis of a prepaid loan.
3. The minimum amount of the loan (€ or US \$ 25 – 100) depends on the volume of the subscription. After every receipt of a shipment of new issues the participant of the New Issues Service will supply the loan to the original minimum amount.
4. The participant of the New Issues Service takes care that there will always be a credit balance and sufficient funds on the account of the New Issues Service of LISC Chapter 7.
5. In case of insufficient funds delivery of new issues will be stopped and no new issues will be ordered.
6. New issues according to the subscription form will always be accepted and paid for.
7. Amendments in the subscription or termination of the subscription will be made in writing. Termination of the subscription is subjected to three months' notice.
